Coach Access to Ma Wan Park

Notes for Application for Inclusion in the Master List

- 1. 馬灣上道路禁區許可證將由運輸署批核,馬灣公園服務處(服務處)將統籌申請禁區許可證事官。
- 2. 只有經核准列入「主體表」內之旅遊巴才可向服務處申請禁區許可證,以進入馬灣路。「主體表」 將會定期更新。
- 3. 申請者可用一張申請表爲多輛非專營巴士進行登記。
- 4. 有關非專營巴士必須持有效的車輛登記文件及客運營業證,並獲准提供遊覽、酒店或合約式出租服務(即 A01, A02 或 A08。復康巴士則必須已獲 B03 批註)。
- 5. 申請者需確保遞交之資料及文件均屬詳盡確實。服務處並不對申請者所提供的失實資料負責。
- 6. 申請者需先填寫「**申請列入主體表**」的表格(表 1),並夾附相關文件副本後,再以郵寄、傳真或 親自遞交等方式交至服務處。
- 7. 除非有關申請不獲接納,否則服務處將不會對申請結果作出個別通知。如有須要申請者可於遞表 七個工作天後致電服務處查詢申請結果。此外,若申請已獲核准而申請者有任何資料或文件上的 更新,應即時填寫相同表格通知服務處。
- 8. 此表只供申請者將旅遊巴列入主體表內,旅遊巴在每次進入馬灣前均須另行向服務處填交「旅遊 巴進入馬灣公園申請表」(即表二)。
- 9. 服務處保留隨時修訂上述各項規定而毋需預先通知申請者之權利。
- 1. The Prohibited Zone Permit (PZP) for roads in Ma Wan will be issued by the Transport Department. Ma Wan Park Management Services Office (MSO) will co-ordinate the applications for PZP.
- 2. Only coaches approved for inclusion in the Master List will be eligible for applying PZP from MSO. The Master List will be updated periodically.
- 3. The applicant can make application for more than one coach using a single form.
- 4. The non-franchised buses under application should be issued with a valid Vehicle Registration Document and Passenger Service Licence Certificate, and endorsed for operation of tour, hotel or contract hire services (i.e. A01, A02 or A08. For rehabus, B03 endorsement is required).
- 5. The applicant should ensure that all information and documents submitted are true and valid. MSO will not be liable for any incorrect information provided by the applicant.
- 6. The applicant should complete the "Application for Inclusions in the Master List (Form 1)", and enclose copy of relevant documents, then submit via post, fax or by hand to MSO.
- 7. Unless the application is failed, the result will not be notified individually. The applicant may enquire the application result 7 working days after the submission of the Form 1. Besides, if the application is approved, the applicant should inform MSO immediately (by filling in the same application form) in the event that there is any update to information or document provided in the submission.
- 8. This Form is for application to include the coach in the Master List only. It is necessary to fill in and submit the "Application Form for Access of Bus to Ma Wan Park" (i.e. Form 2) to MSO every time before entering Ma Wan.
- 9. The above guide lines are subject to change without prior notice.
